## Water Conservation Rebate Program Terms – Important Updated January 2023

The Qualifying devices must be installed on sites located within the district that are served by California American Water. By signing the application, I acknowledge and agree to the following:

- ❖ The purchased device(s) must be new and must be an approved model. Water Sense Certified Products can be found at <https://www.epa.gov/watersense/watersense-products>
- ❖ Complete applications will be processed in the order received. This offer is subject to available funding.
- ❖ The rebate amount will not be higher than the cost of the device plus installation if professionally installed but will never exceed the rebate amount allowed.
- ❖ Accounts must be current in order to receive rebate.
- ❖ Qualifying Devices and Amounts (**Meadowbrook Only**):
  1. Turf Exchange Rebate – call for required pre-inspection and approved application
  2. WaterSense labeled Flushometer – valve Water Closet -Self flushing units not qualified – (1.28 gpf or less) up to \$200\*
  3. WaterSense Labeled tank toilet installed in commercial building HET1.28 gpf– up to \$125
  4. Water Sense Labeled Tank toilet installed in commercial building UHET1.0-.8 gpf – up to \$150
  5. Commercial WaterSense Labeled Efficiency Clothes Washer -- \$500 (Call for a list or visit website)
  6. (0.5 gpf) WaterSense labeled flushing Urinals -- \$200 Pint Urinal -- \$250
  7. Zero Water Consumption Urinal – up to \$300
  8. Commercial Smart Controller (Must be Water Sense Certified) -- \$50 per station
  9. WaterSense Rain/Weather Sensor attached to an irrigation system -- \$40
  10. High Efficiency Sprinkler Nozzles (minimum 15) -- \$4 and \$10 for large Rotors (SWAT Tested)
- ❖ **Old toilets being replaced must be 3.5gpf or higher to qualify. We no longer rebate 1.6gpf toilets unless you are replacing it with UHET 1.0 gpf or less.**
- ❖ Device(s) must be installed at the address identified on the application prior to submittal of this application.
- ❖ All devices for which a rebate is issued are subject to **on-site installation verification** inspection. If device installation cannot be verified, the payee must reimburse the Rebate Program for rebate funds received, including all associated processing costs.

### **Rebate Program Instructions and Terms**

- ❖ Confirm that the device(s) is identified on the list of approved products. For HET rebates, the model numbers for both tank and bowl must be EPA WaterSense Certified. - ❖ Attach the original sales receipt or professional paid invoice with proof of payment to this application. Receipt(s) must include the make and model of the device(s) purchased. Receipts must be received within the 120 days of purchase.
- ❖ Attach a copy of your most recent water bill for the address where the device(s) were installed
- ❖ Retain a copy of this application and the sales receipt for your records. The Rebate Program is not responsible for materials lost or delayed in the mail, including misdirected mail. **Please provide a self-addressed stamped envelope if you would like your receipts returned.**
