<b>High-Efficiency Clothes Washer (HECW): \$500</b>	Commercial customers only* For clothes washer(s), the device(s) must not have a (IWF) water factor of more than 4.
<b>Pool Covers \$50 for new manual covers \$200 for permanent mechanical covers</b>	Must cover at least 85% of pool surface area (multi-piece or single-piece okay) Must submit photograph of pool cover covering pool be eligible for this rebate Must be made of material that decreases evaporation rate, ie. solar blankets (mesh covers do not qualify) New pool covers only; may reapply for new rebate after two (2) years if funds still available.

\*Residential customers do not qualify for in-house clothes washer rebates; residential customers may be eligible to apply for a clothes washer rebate through SoCal WaterSmart ([www.socalwatersmart.com](http://www.socalwatersmart.com))

- ❖ Customer must be an account holder for a property located in the California American Water Ventura County Service District.
- ❖ The purchased device(s) must be new and must qualify as an approved product.

- ❖ The rebate amount will not be higher than the cost of the device plus installation if professionally installed, and will never exceed the rebate amount allowed. This offer is subject to available funding.
- ❖ Device(s) must be installed at the California American Water service address identified on the application ("Property Address" prior to submitting application.
- ❖ All devices for which a rebate is issued are subject to on-site installation verification inspection. If device installation cannot be verified, the payee must reimburse the Rebate Program for rebate funds received, including all associated processing costs.
- ❖ **Please enclose:**
  - **Original sales receipt.** Receipt(s) must include the make and model of the device(s) purchased. Receipts for all covered appliances and parts must be received within the 120 days of purchase. Please include a self-addressed stamped envelope if you would like your receipts returned.
  - **Your most recent California American Water bill** for the address where the device(s) were installed.
  - **Written authorization if needed.** If applicant's name is not listed as the account holder, written authorization from the account holder must be submitted to receive a rebate. Tenants must get owner authorization in writing to receive rebate.
